The Intergovernmental Development Authority "IGAD" has received financing from the African Development Fund *hereinafter* called the Bank toward the cost of the Drought Resilience and Sustainable Livelihoods Programme in the Horn of Africa -Project II (DRSLP II). Save the Children International as an Implementing Agency (IA) intends to apply part of the proceeds of the project toward payments under the contract for **Construction/Rehabilitation of Feeder Road in Somaliland 33KM from Borama to Baki (Lot 1)**.
- 2. Save the Children International, Hargeisa office now invites sealed Bids from eligible Bidders for Construction/Rehabilitation of Feeder Road in Somaliland 33KM from Borama to Baki (Lot 1) within 9-month completion period.
- 3. Bidding will be conducted through the Open Competitive Bidding (National), OCBN procedures as specified in the Bank's <u>Procurement Framework</u> dated October, 2015 and is open to all eligible Bidders as defined in the Procurement Framework.
