3. Bidding will be conducted through the Open Competitive Bidding (National), (OCBN) procedures as specified in the Bank's [Procurement Framework](#) dated October, 2015 and is open to all eligible Bidders as defined in the Procurement Framework.

7. All Bids must be accompanied by a Bid Security in the form of an unconditional bank guarantee enforceable in Somalia using the format provided in the Bidding Document and in the amount of **US Dollars of 2,600**.
