#### 1. INTRODUCTION TO SAVE THE CHILDREN

#### 2. EXPRESSION OF INTEREST DETAIL

As part of the ongoing situation in the region, Save the Children is interested in exploring alternative supply routes for aid to be distributed into Gaza. One option is for the shipment of goods into Cyprus which are then transported onwards via a sea route to Gaza.

Save the Children is launching this Expression of Interest to gain a better understanding of the market and to get a better understanding of what supply options exist. We are inviting both existing and prospective suppliers to submit their interest.

Depending on the situation in Gaza and Save the Childrens chosen strategy, a follow up procurement activity may be initiated to formally select and contract with suppliers. For the avoidance of doubt – this Expression of Interest will not directly lead to a Contract and is for informative purposes only.

#### 3. SUBMISSION FORMAT

Suppliers wishing to express interest and share details of their capabilities, should do so by completing the 'Bidder Response Template'. This template has been specifically created to allow suppliers to provide the relevant information in the easiest / most simple format.

#### 4. SPECIFICATIONS

We have deliberately not provided detailed specifications as we are open to understand all viable supply options. Therefore, please provide information relating to which specification of product you think is most appropriate.

For the avoidance of doubt, Save the Children is interested in suppliers who can supply either all or some of the goods listed. If you are only able to provide certain categories of items, and not the full list, this is acceptable.
