- 4. Unsealed envelope and late offers will not be considered.
- 5. - Then bidder(s) will be technically evaluated and will be given a score out of 100 points.
- The bidder(s) passing the minimum requirement threshold from the technical evaluation (70 points) will be then further considered for the financial evaluation.
- Then bidder(s) will be financially evaluated and will be given a score out of 30 points. The price is scored proportionally from the lowest price received.
- The awarded bidder will be the one with the best weighted average out of 70% for the Technical offer and 30% for the Financial one.
