Document 2 – Background and Services Specification

1. Background

About Christian Aid

Christian Aid is a Christian organisation that insists the world can and must be swiftly changed to one where everyone can live a full life, free from poverty. We work globally for profound change that eradicates the causes of poverty, striving to achieve equality, dignity and freedom for all, regardless of faith or nationality. We are part of a wider movement for social justice. We provide urgent, practical and effective assistance where need is great, tackling the effects of poverty as well as its root causes.

We are the international development and advocacy agency for 41 sponsoring churches in Britain and Ireland, and part of the church community worldwide. The work we do reaches beneficiaries of all faiths and none. The way we operate is through a partner model, as we believe we can achieve even more when we team up with others who are already working within the communities we support.

About Governance and Rights programme

Christian Aid is committed to fostering civic spaces that amplify the voices of the poorest and most marginalised communities, with a particular focus on Governance and Rights. Through our work, we aim to empower these communities by promoting accountable governance, transparent resource allocation, and equitable service access. However, restrictive policies and authoritarian leadership in many regions curtail civic engagement and hinder civil society's ability to advocate for their rights effectively. This study is part of Christian Aid's broader 2024-25 "Deep Dive" research initiative into the Governance and Rights Theme.

2. Objectives

This research project emphasizes a participatory, qualitative-led approach to data collection, with quantitative data collection serving as supportive context, allowing field teams in Zimbabwe and India to gather comprehensive, grounded insights. Christian Aid is looking for a consultant to focus on making these methods practical, accessible, and adaptable for effective, on-the-ground use by country teams, providing ongoing remote support throughout the data collection and analysis processes.

The selected consultant will examine Christian Aid's contributions to civic space and governance, focusing on two major sub-themes:

- 2.1 Citizenship Rights and Civic Space investigating how civil society can protect civic space, mobilise citizen participation, and engage faith-based organisations and alliances to hold power structures accountable.
- 2.2 **Transparency, Accountability, and Just Financing** understanding Christian Aid's role in influencing public economic policy, especially regarding governance, budgeting, and economic justice for marginalised communities.

The research project aims to generate evidence-based insights to:

- Strengthen Christian Aid's Governance and Rights work by analysing methods that effectively support civic space and voice;
- Identify best practices and emerging strategies for working in restrictive civic environments; and



• Inform Christian Aid's programme strategies, especially concerning citizen participation, inclusive governance, and economic justice.

3. Scope and Geographic Coverage

The selected supplier will be expected to actively support the Project Manager, Thematic Adviser and Research Adviser and act as a Research Lead with technical support to the project team. They will participate remotely in the identification of key issues and questions, research methodology, research exercises, data analysis and drafting of results. They will lead in drafting the final research report for Christian Aid. By engaging with the process from the outset, the consultant will ensure alignment with the project's objectives and gain a deeper understanding of the context, contributing to practical and actionable insights.

The consultant's responsibilities will include:

- **Participating in Co-designing the Research Framework**: Collaborating remotely with the project and country teams to develop research methodologies, tools, and field exercises that are contextually relevant and feasible for implementation in Zimbabwe and India.
- **Providing Support to Field Teams**: Offering ongoing guidance and capacity-building to facilitate participatory qualitative and quantitative data collection.
- **Conducting a Literature Review**: Reviewing existing studies to establish the research context and identify gaps.
- Analysing Data: Synthesizing qualitative and quantitative findings to produce evidencebased insights
- **Country Research reports**: supporting the detailed write-up of the research in each country
- Leading the Report Writing Process: Drafting a comprehensive research report with global detailed findings, actionable recommendations, and a concise summary version for broader dissemination.

The consultant will address the following research question, with a focus on evidence-based insights:

• What methods are most effective for increasing the quality of inclusive civic space? – in terms of Christian Aid's experience and learning from Governance and Rights programming in Zimbabwe and India.

4. Requirements

Your proposal should cover but not limited to the following elements:

5. Evaluation Criteria

Proposals will be evaluated on the basis of best value for Christian Aid as a combination of commercial affordability, quality of service provision and technical capability. Specifically, the evaluation criteria will include but not limited to the following:

- Quality and completeness of proposal
- Technical approach and methodology including the proposed timeframe
- Relevant experience
- Organisational/Personnel capacity and expertise
- Clarity of proposed fee structure and level of fees



Document 3 – Code of Conduct for Suppliers

ETHICAL STANDARDS

We strive to purchase and source goods, services and works which are produced and delivered under conditions that do not involve the abuse or exploitation of any persons.

We look to work in partnership with suppliers to ensure that:

- Employment is freely chosen
- Freedom of association and the right to collective bargaining are respected
- Working conditions are safe and hygienic
- No exploitation of children
- Living wages are paid
- Working hours are not excessive
- No discrimination is practised
- Regular employment is provided
- No harsh or inhumane treatment is allowed
- Safeguards are in place to protect against human trafficking

Specifically, we will not enter any procurement relationship with companies that have:

- Significant Involvement in the arms trade
- Extracted harsh and inequitable payments from developing countries for debts (Debt Relief (Developing Countries) Act 2010)
- Inhibiting access to affordable medicine according to the WHO Model Lists of Essential Medicines
- Tobacco marketing in developing countries
- Significant involvement in the alcohol industry
- Significant involvement in gambling
- Significant involvement in pornography
- Insufficient safeguards to end the use of conflict minerals where applicable (Kimberley Process/EU Regulation)
- Involvement in terrorism

ENVIRONMENTAL STANDARDS

We strive to purchase and source goods, services and work, which have the least negative impact on the environment.

We make procurement decisions and look to work in partnership with suppliers to ensure that:

- Environmental, Social and Governance (ESG) issues are at the forefront of good corporate governance.
- Purchasing decisions are based on whole life principles to purchase more durable products with a longer life-span and maximising environmental sustainability
- Undue and unnecessary use of materials is avoided, and recycled materials used whenever possible. Effective controls of waste in respect of ground, air and water pollution are adopted. In the case of hazardous materials emergency response plans are in place.
