Ukraine is seeking for a service provider to optimize the PRASA approach (Participatory Risk and Security Analysis) for its further integration into recovery programs at the national, regional and community levels in close cooperation with local authorities, including the State Migration Service of Ukraine and the Ministry of Social Policy of Ukraine.

Payment will be made within the framework of the **Project "Building Back Better II - Building, rebuilding, improving. Creating a favorable environment for children and adolescents in Ukraine"** (hereinafter – the project), **funded by the German Federal Ministry for Economic Cooperation and Development (BMZ)**.

Requirements (to be met in full):

Compliance of the application with the customer's requirements and the terms of the ToR; Proven qualification and experience in providing the relevant services.

Acceptable budgeted price and terms of service provision.

3. Submission of offers

Offers must be received before the deadline specified in the "Request for Quotations".

4. Evaluation of offers

Shortlisted suppliers may be invited to discuss their proposals in more detail at Plan's discretion.

Plan International, at its sole discretion, will select the successful RFQ. Plan international shall

be free to:

- Accept the whole, or part only, of any submitted offers,
- Accept none of the proposals,
- Republish this Request for Quotations.

Plan International reserves the right to keep confidential the circumstances that have been considered for the selection of the offers.

Part of the evaluation process may include a presentation from the supplier and a sitevisit by Plan International staff, to offices.

Women-owned businesses and companies actively engaged or advancing gender equality and women empowerment in the workplace are especially encouraged to apply.

Value for money is very important to Plan International, as every additional £ saved is money that we can use on our humanitarian and development work throughout the world.

Plan International may award multiple contracts and all contracts will be non-exclusive.

5. Contract Payment terms

Please note that, if successful, Plan International's standard terms of payment are maximum **30 days** after the end of the month of receipt of invoice, or after acceptance of the Services, if later, or according to payments terms indicated in relevant Terms of reference. Supplier Registration Form must be filled in for identifying the bank account for the payment.

6. Plan International's Ethical & Environmental Statement

The supplier should establish environmental standards and good practices that follow the principles of ISO 14001 Environmental Management Systems, and in particular to ensurecompliance with environmental legislation.

7. Clarifications
